### ENTRY REQUIREMENTS

*\*For other equivalent qualifications, please consult our programme counsellor*

- i. A Bachelor's degree (Level 6, MQF) in the field or related field with a minimum CGPA of 2.75 or the equivalent as accepted by the HEP Senate; OR
- ii. A Bachelor's degree (Level 6, MQF) in the field or related field with a minimum CGPA of 2.50 and not meeting CGPA of 2.75 can be accepted, subject to rigorous internal assessment; OR
- iii. A Bachelor's degree (Level 6, MQF) in the field or related field with a minimum CGPA of 2.00 and not meeting CGPA of 2.50 can be accepted, subject to a minimum of 5 years' relevant working experience and rigorous internal assessment; OR
- iv. Candidates without a related qualification in the field/s or working experience in the relevant fields must undergo appropriate prerequisite courses determined by the HEP and meet the minimum CGPA based on (i) to (iii)
